

TO PRO-DUCE AN APPROVED UNIT LOAD, ALL PERTINENT PRO-CEDURES, SPECIFICATIONS AND CRITERIA SET FORTH WITHIN THE BASIC DRAWING WILL APPLY TO THE PRO-CEDURES DELINEATED IN THIS APPENDIX. ANY EXCEP-TIONS TO THE BASIC PROCEDURES ARE SPECIFIED IN THIS APPENDIX.
- B. DIMENSIONS, CUBE AND WEIGHT OF A PALLET UNIT WILL VARY SLIGHTLY DEPENDING UPON THE ACTUAL DIMEN-SIONS OF THE BOXES AND THE WEIGHT OF THE SPECIF-IC ITEM BEING UNITIZED.
- C. INSTALL EACH HORIZONTAL STRAP TO BE LOCATED AS SHOWN. HORIZONTAL STRAPS MUST BE TENSIONED AND SEALED AFTER THE APPLICATION OF TIEDOWN STRAPS.
- D. INSTALL EACH TIEDOWN STRAP TO PASS UNDER THE DECK/STRINGER BOARDS OF THE PALLET AND TO BE LOCATED AS SHOWN.

E. THE FOLLOWING AMC DRAWINGS ARE APPLICABLE FOR OUTLOADING AND STORAGE OF THE ITEMS COVERED BY THIS APPENDIX.

- F. IF ITEMS COVERED HEREIN ARE UNITIZED PRIOR TO ISSUANCE OF THIS REVISION TO THIS APPENDIX, THE BOXES NEED NOT BE REUNITIZED SOLELY TO CONFORM TO THIS REVISION.
- G. THE UNITIZATION PROCEDURES DEPICTED HEREIN MAY ALSO BE USED FOR UNITIZING 120MM MORTAR CAR-TRIDGES WHEN IDENTIFIED BY DIFFERENT NATIONAL STOCK NUMBERS (NSN) THAN WHAT IS SHOWN ON PAGE 2, PROVIDED THE BOX PACK DOES NOT VARY FROM WHAT IS DELINEATED HEREIN. THE EXPLOSIVE CLASSI-FICATION OF OTHER ITEMS MAY BE DIFFERENT THAN WHAT IS SHOWN.
- H. THE STYLE 1 PALLET DELINEATED IN THE DETAIL AT LEFT NEED NOT HAVE CHAMFERS OR STRAP SLOTS AS SPECIFIED WITHIN MILITARY SPECIFICATION MIL-DTL-15011 WHEN USED FOR THE UNITIZATION OF ITEMS COVERED BY THIS APPENDIX.
- J. BOXES MUST ALL BE ORIENTED IN THE SAME DIRECTION ON THE PALLET TO ALLOW THE INTERLOCKING DEVICES TO PROPERLY ENGAGE.
- K. ALL WOODEN DUNNAGE SHALL BE PRESERVATIVE TREATED IN ACCORDANCE WITH GENERAL NOTE "AA" IN THE BASIC PROCEDURES, AND HEAT TREATED IN AC-CORDANCE WITH GENERAL NOTE "JJ" IN THE BASIC PROCEDURES.
- L. IF THERE IS NEED FOR FILLER ASSEMBLIES AND AT LEAST TWO PALLET UNITS ARE BEING CONSTRUCTED, NOT MORE THAT 20 FILLERS WILL BE INSTALLED IN ANY ONE PALLET UNIT. ADDITIONAL FILLERS CAN BE PUT IN A SECOND PALLET UNIT AS REQUIRED WHEN THE QUANTITY OF 20 FILLERS IN THE FIRST REDUCED PAL-LET UNIT IS INSUFFICIENT TO SATISFY THE TOTAL RE-DUCTION NEEDED. USING TWO PALLET UNITS TO SAT-ISFY THE PALLETIZATION CRITERIA APPLICABLE TO LESS-THAN-FULL PALLET UNITS IS AN EXCEPTION TO THE BASIC PROCEDURES. HOWEVER, THE EXCEPTION IS NECESSARY FOR THE AMMUNITION PACK COVERED BY THIS APPENDIX TO MOST EFFECTIVELY GET AN AC-CEPTABLE, COMPACT AND SOUND PALLET UNIT.
- M. DIMENSIONS GIVEN FOR DUNNAGE PIECES ARE AP-PROXIMATE AND MUST BE VERIFIED IN ACCORDANCE WITH GENERAL NOTE "Z" IN THE BASIC PROCEDURES. THESE ASSEMBLIES MUST NOT PROTRUDE PAST THE TOPS AND/OR SIDES OF THE PA154 BOXES. THEY MAY BE SHORTER, PROVIDED THE TIEDOWN STRAPS ARE PREVENTED FROM DAMAGING THE EDGES OF THE BOX-ES. THE HORIZONTAL PIECE MUST FIT AGAINST THE HANLE OFR LATCH ASSEMBLY.
